CLERK ADMINISTRATOR'S REPORT

Its almost Spring time!

It will be time for our annual clean-up soon and we would like to ask for you to assist the Village in the beautification efforts. Please remove any personal property from Village right of ways so we can mow and remove weeds from these areas. Our 11th Street project is in the final permitting stage and construction for water and wastewater line replacement will start this Spring. It is imperative the right of ways be cleared so we get the project completed without delay.

The Village still has funding to purchase water rights if you or anyone you know may be interested in selling some to the Village. We are looking for approx. 15 acre foot to purchase.

The beautification committee meets the 4th Tuesday of the month at 5:30 if you would like to join us and give us your input.

The Water Rehabilitation Project plans are in the process of final review by USDA and that project should be taking off this Summer.

Jefferson Street plans are in the final permitting approval stage and this project will be done once warm weather is here.

Capital outlay for this session has been submitted and we hope to be awarded some good projects.

The Sawmill Project is still in the organizing stage and the steps for implementation are moving along.

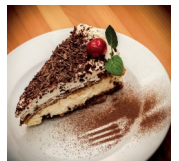
CIMARRON MUNICIPAL SCHOOLS
