**Village of Cimarron Regular Municipal Election
March 6, 2018**

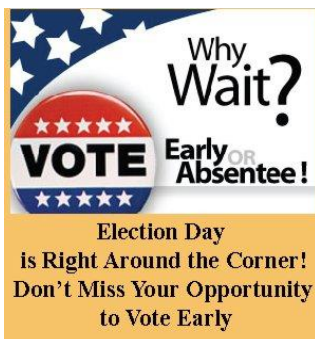
The Village of Cimarron will hold a Regular Municipal Election on Tuesday, March 6, 2018 for the purpose of electing one (1) Mayor for a four year term, two (2) Councilors for a two year term, and two (2) Councilors for a four year term.

Village Mayor & Council Positions

Any registered elector of the Village of Cimarron may file their Declaration of Candidacy on Tuesday, January 9, 2018, at the Municipal Clerk's Office from 8:00 a.m. to 5:00 p.m.. **This is the only day to file as a Candidate and be included on the ballot.** There will be one additional day to file for office as a Write-In Candidate and that is on Tuesday, January 16, 2018, at the Municipal Clerk's Office from 8:00 a.m. to 5:00 p.m. The ballot will only provide a blank line for any certified write-in candidates. **All prospective Candidates are encouraged to contact the Municipal Clerk for Candidate packets.**

Voting Eligibility

To be eligible to vote in this Election, you must be a registered elector whose registered address is within the Village Limits of the Village of Cimarron. If you are not currently registered to vote, you must do so with the Colfax County Clerk no later than 5:00 p.m. on Tuesday, February 6, 2018. Since the registered voters within the boundaries of the Village of Cimarron elect the Town Mayor and Councilors, it is particularly important for voters to be registered at the address where they presently reside. If you have moved or changed your name since the time you registered to vote, you should change your voter registration to reflect your current name and address.



Absentee & Early Voting

Absentee voting on paper ballots through the mail will be available for this election and can be obtained by contacting the office of the Municipal Clerk. Absentee voting applications can be mailed beginning at 8:00 a.m. on Tuesday, January 30, 2018, and Early Voting in person on paper ballots begins at 8:00 a.m. on Wednesday, February 14, 2018. Absentee voting on paper ballots and Early Voting on paper ballots ends at 5:00 p.m. on Friday, March 2, 2018. Absentee and Early Voting will be conducted in the Office of the Municipal Clerk at Village Hall, 356 E 9th Street, during regular business hours, which are Monday through Friday, 8:00 a.m. to 5:00 p.m.
