Village of Cimarron Regular Municipal Election November 2, 2021

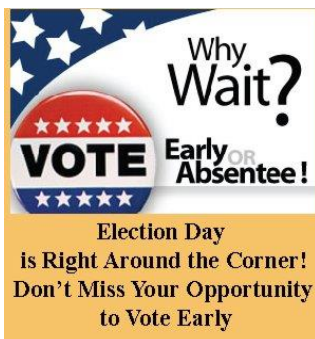
The Village of Cimarron will hold a Regular Municipal Election on Tuesday, November 2, 2021 for the purpose of electing one (1) Municipal Judge for a four year term, one (1) Mayor for a four year term, two (2) Councilors 4 year term. There are one Mayor, one Judge, and two Council positions to be elected.

Village Council Positions

Any registered elector of the Village of Cimarron may file their Declaration of Candidacy on Tuesday, August 24, 2021, at the Colfax County Clerk's Office from 9:00 a.m. to 5:00 p.m. **This is the only day to file as a Candidate and be included on the ballot.** There will be one additional day to file for office as a Write-In Candidate and that is on Tuesday, August 31, 2021, at the Colfax County Clerk's Office from 9:00 a.m. to 5:00 p.m. The ballot will only provide a blank line for any certified write-in candidates. **All prospective Candidates are encouraged to contact the Village Hall or the Colfax County Clerk for Candidate packets.**

Voting Eligibility

To be eligible to vote in this Election, you must be a registered elector whose registered address is within the Village Limits of Cimarron. To participate in the election, the deadline to register to vote or update and existing voter registration is twenty eight days (28) prior to that election. October 5, 2021 through October 30, 2021 at the Colfax County Clerks Office. Since the registered voters within the boundaries of the Village elect the Village Mayor, Judge, & Councilors, it is particularly important for voters to be registered at the address where they presently reside. If you have moved or changed your name since the time you registered to vote, you should change your voter registration to reflect your current name and address.



Absentee & Early Voting

Absentee voting on paper ballots through the mail will be available for this election and an application can be obtained by contacting the office of the Colfax County Clerk or by requesting an application at NMvote.org. Absentee voting applications and ballots can be mailed beginning at 8:00 a.m. Tuesday, October 5, 2021.

Early voting begins October 5, 2021 and ends October 30, 2021 at the Colfax County Courthouse between 7:00am and 5:00pm Monday through Thursday. Early Voting in person on electronic voting machines will be at Cimarron Village Hall during the hours of 10:00am-4:00pm on Wednesday, October 22, 2021.
